Retro Reflective Tapes : Origin & Importance...

An Order passed by The Supreme Court, New Delhi on Writ Petition No. 295/2012, Supreme Court have formed **Supreme Court Committee on Road Safety**.

The committee has ordered that Road Accident is a major flaw that need to be reduced by 10% on every year. As per the study, it has been found that Road accident does happen in night due to low reflection of reflective tape / reflectors and thus driver cannot see ahead vehicle due to non-visibility of slow moving vehicles and falls into an accident.

On the basis of guidelines given by the committee, Transport Commissioner Office, Bandre Mumbai published guidelines vide circular no. MVR/-710/CR-1011/ KA.2(4)/Outward No.3236 dated 05.03.2021, to increase intensity of reflection of **Reflector**.

As per guidelines mentioned in circular, **Maharashtra Govt. has mandated to install authorized and certified AIS 089 and AIS 090 reflective tape, reflector and rear marking tapes on all commercial vehicles considering amendment done in Central Motor Vehicle Act 1989 (104 to 104e).**

As per Guidelines and to Authenticate Genuinity, **Govt. has also mandated QR Code Scanning system for each reflective tapes / Reflectors.**

Maharashtra Government Initiative:

Abiding to the order issued by the Supreme Court, The Maharashtra State Government has made mandatory to fix retro-reflective tapes on all commercial vehicles irrespective of their year of manufacturing.

Even three-wheelers including e-rickshaw and e-carts shall be affixed at the front with a white genuine reflective tape and at the rear with a red reflective tape running across the width of the body.

These changes are being introduced to increase their visibility in dark and to prevent road accidents.

Transport Commissioner Office, Mumbai have published Request for Proposal (RFP) for manufacture / supply of certified AIS 089 and AIS 090 Reflectors, Reflective Tapes and Rear Marking Plates/Tapes. In Bidding, 3 companies has been authorized to manufacture and supply of Reflectors, Reflective Tapes and Rear Marking Plates/Tapes vide their respective Work Order allotted by Transport Commissioner Office.

Maharashtra Govt. has mandated to install genuine Retro Reflective and Rear Marking Tapes.

To Authenticate the Genuinity of the Reflectors, Maharashtra Govt. come up with QR Code Scanning to certify the same.

RTO issue Fitness Certificate to the vehicles which has its genuine QR Code and its valid certificate
